
The Shellfish Aquaculture Industry of Virginia

The shellfish culture industry of Virginia provides a significant economic benefit to the Commonwealth, with an annual farm-gate value approaching \$50 million and a total impact close to \$100 million. Virginia has become the leading producer of hard clams and Eastern oysters with the majority of production coming from a system of vertically integrated private hatcheries.

Prior to Mike's current position as director of a trade organization of shellfish farmers, he served as the Virginia Sea Grant Marine Extension aquaculture specialist. Mike will provide an overview of the Virginia shellfish aquaculture industry, including production information and a list of challenges facing the industry, and will answer the question "Why has Virginia Shellfish Aquaculture been so successful?"
